# Cleveland Clinic Healthy Choice Enrollment Guide | New Caregiver Program

The Healthy Choice program is a voluntary premium discount program from the Employee Health Plan (EHP) that rewards you for taking action to manage your health. The program provides resources to help you save on your premium and support your overall well-being. As a new caregiver\* at Cleveland Clinic, you will be eligible to join the New Caregiver Program. Once you participate and complete the required tasks, you'll earn a discount on the current year's and next year's health plan premium, which will be reflected in 1-2 pay cycles.

You must be enrolled in the Employee Health Plan to participate in the New Caregiver Program.

#### Log into your Healthy Choice Portal

To get started, scan the QR code or click the logo to download the App. You will need your health plan ID and date of birth to create your account and log in.











## 2 Connect an activity device

Now that you have created your Healthy Choice account, it is time to connect your activity device to the Healthy Choice App.

- Within the Healthy Choice App select the three dots and tap "Link Device", then select the type of device you are connecting.
- Click here for step-by-step instructions or visit clevelandclinic.org/healthychoice.
- A one-time \$115 credit is available in the portal to use toward the purchase of an activity device. Log in to your portal and select "Device Store" to learn more.

### Complete 13 Awareness videos

Log in to your Healthy Choice portal.

- Select "Dashboard" then tap "View" under the "New Caregiver program Module Track".
- Complete all 13 videos.

## 4 Finish strong by the final deadline

If you were hired between Jan. 1–Oct. 31, complete the required tasks by Dec. 28 to earn a premium discount on your current year's health plan premium. The sooner you complete the required tasks; the sooner you will receive the discount. The discount will take 1-2 pay cycles to be reflected in your Workday portal and paycheck. If you were hired between Nov. 1–Dec. 31, contact the EHP Wellness Specialists at 216.986.1050, option 3 for more information.

#### **Additional Information**

\*2026 New Caregiver Eligibility Definition: A caregiver is eligible for the New Caregiver Program if they meet **One** of the following criteria:

- Caregiver has not been employed at Cleveland Clinic within the 12 months prior to their most recent hire date.
   OR
- Caregiver is newly enrolled in EHP benefits due to open enrollment or a life event change. If you're newly married, please contact an EHP Wellness Specialist at 216.986.1050, option 3.
